

KNOW ALL MEN BY THESE PRESENTS, that Lakehead Pipe Line Company, Inc., a Delaware Corporation, whose address is 3025 Tower Avenue, Superior, Wisconsin, 54880, for a valuable consideration, hereby disclaims and releases any and all rights it may have acquired under and by virtue of that right of way and easement grant executed by Anna Zielinski, Grantor, October 18, 1967, and recorded in the Office of the Register of Deeds in and for Adams County, Wisconsin, in Volume 157 of Records, pages 635-636, over and across the following described lands situated in Adams County, State of Wisconsin, to-wit:

The East half (E 1/2) of the Southwest quarter (SW 1/4) of Section 16, Township 17 North, Range 7 East, Adams County, Wisconsin.

Lakehead Pipe Line Company, Inc., does, however, reserve to itself, its grantees, successors and assigns all of the rights and privileges granted to it by Anna Zielinski, in the right-of-way and easement grant hereinbefore referred to so far as such rights pertain to the following described lands:

The Northeast quarter (NE 1/4) of the Southeast quarter (SE 1/4) of Section 17, Township 17 North, Range 7 East, and the West half (W 1/2) of the Southwest quarter (SW 1/4) of the Southwest quarter (SW 1/4) of Section 16, Township 17 North, Range 7 East, EXCEPT four (4) acres described as the South sixteen (16) rods of the West half (W 1/2) of the Southwest quarter (SW 1/4) of the Southwest quarter (SW 1/4), all in Adams County, Wisconsin.

This release and disclaimer is given for the purpose of releasing the lands first above described from any easement created by the right-of-way and easement grant herein mentioned.

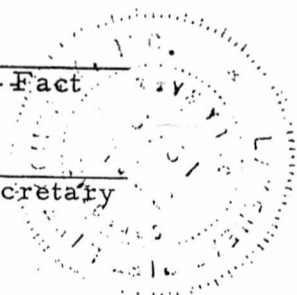
